On line 22, does not Paragraph (a) include Parts (a)(2)(A) through (C)? If so, why not simply say "described in Paragraph (a)"?

Line 25: The WRC is describing "North Carolina State Parks" as an agency in Line 23. There is no such agency. If I am wrong, cite me to the statute creating the same. If the WRC is not regulating the NC Division of Parks and Recreation, what "agency" is it regulating?

Line 25: While an agency can "agree" to be the designated for the purpose of placement and maintenance of regulatory markers, the WRC cannot unilaterally require an agency to do the same by administrative rule. On Line 23 the WRC is requiring agencies to place and maintain markers. The WRC does not appear to have the authority to require those agencies to do the same.
