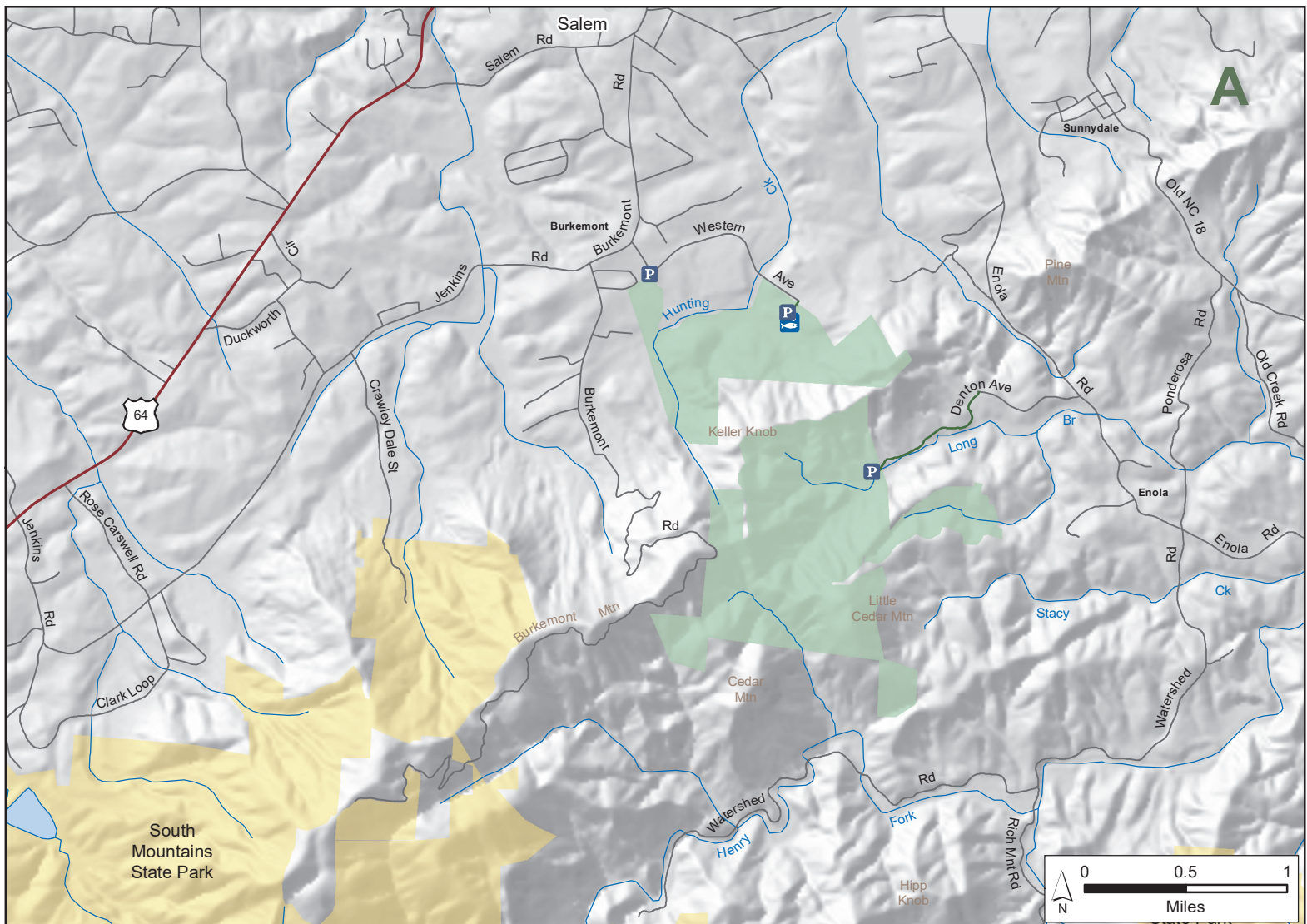


SOUTH MOUNTAINS GAME LAND

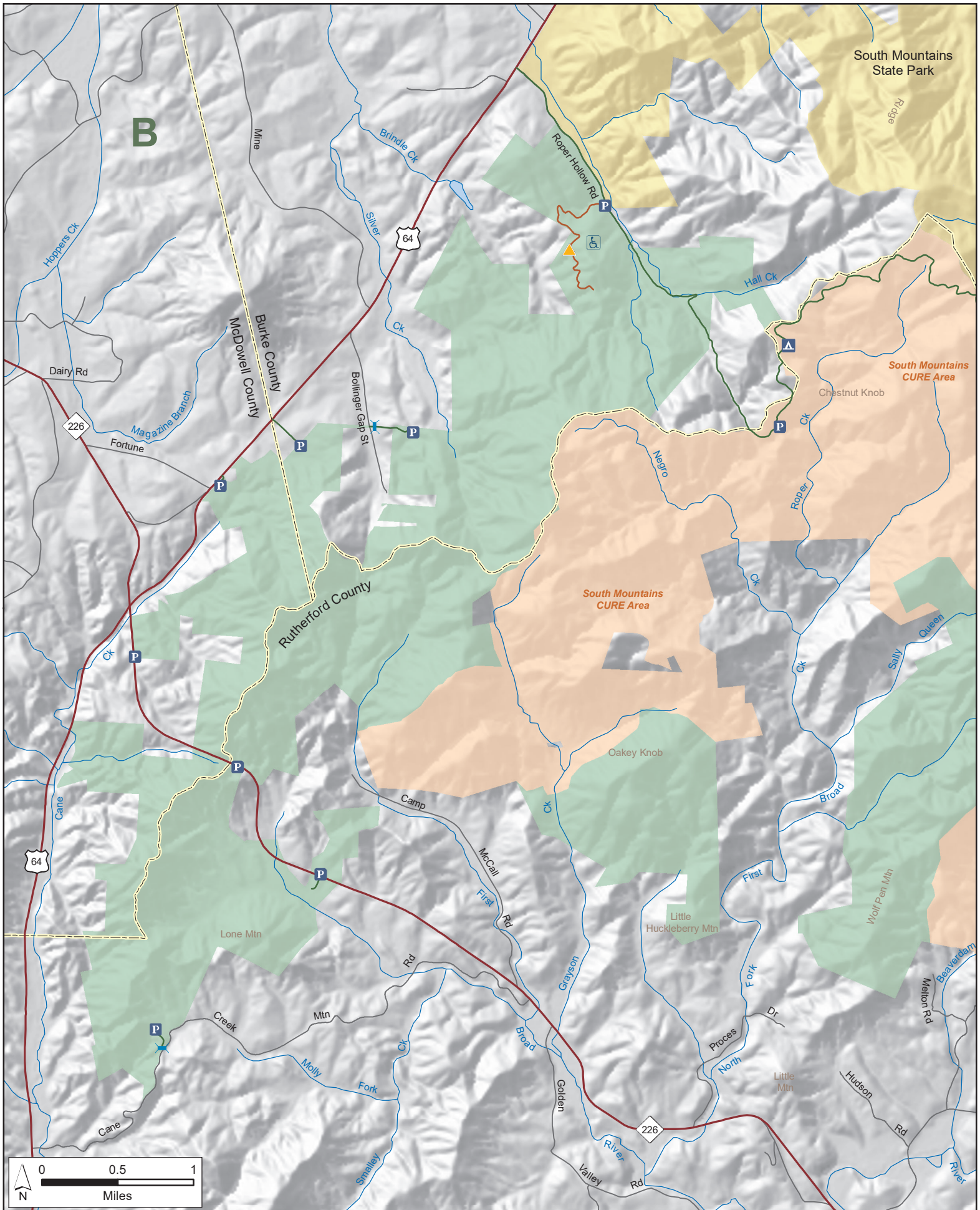

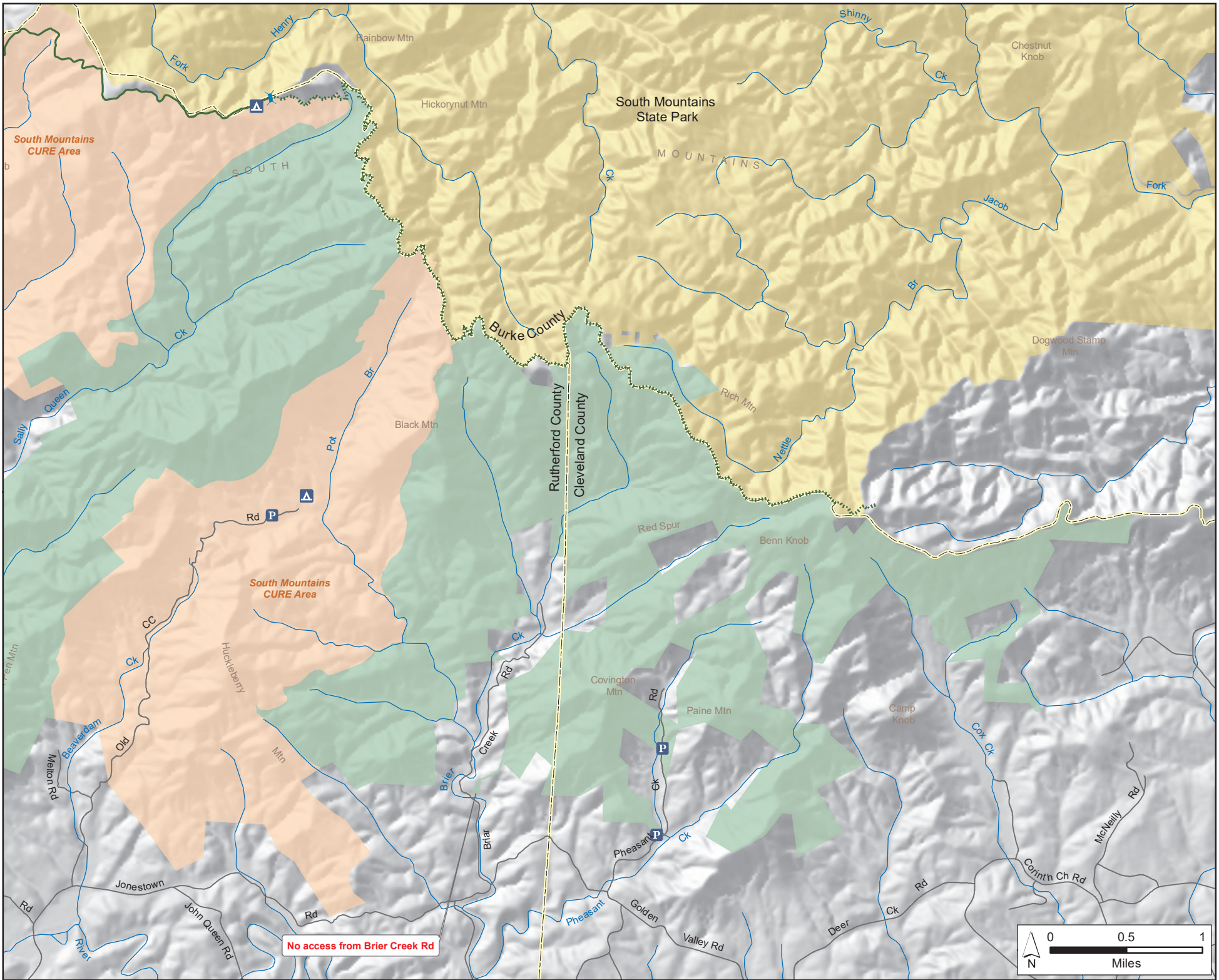
